MINUTES OF THE MARCH 21, 2017, INVESTMENT COMMITTEE MEETING

The Investment Committee ("Committee") of the Board of Regents of the Smithsonian Institution ("Smithsonian") conducted a meeting on Tuesday, March 21, 2017, in the Regents' Room at the Smithsonian Castle in Washington, D.C. CALL TO ORDER / REPORT OF THE CHAIR

Committee Chair Tim O'Neill called the meeting to order at 12:02 p.m. He noted the Committee's appreciation of Roger Sant's invaluable contributions and dedication as a founding member of the Committee in 2005. Mr. O'Neill then introduced new Committee members Henry Ellenbogen and Alice Handy.

APPROVAL OF THE NOVEMBER 15, 2016, COMMITTEE MEETING MINUTES

Upon motion duly made and seconded, the draft minutes of the November 15, 2016, Committee meeting were approved without modification.

ANNUAL PORTFOLIO REVIEW

Chief Investment Officer Amy Chen reported that the Smithsonian Endowment's one-year return as of December 31, 2016 was 6.6% versus the policy benchmark of 6.4%. Ms. Chen reviewed the manager rankings and portfolio attribution analysis. She also reviewed the portfolio liquidity.

FACTOR ANALYSIS AND ASSET ALLOCATION REVIEW

Ms. Chen reviewed the factor analysis and asset allocation study. The Committee agreed with Investment staff's recommendation that no changes be made to the target Long Term Policy Portfolio.

PORTFOLIO IMPLEMENTATION

Ms. Chen sought the Committee's approval for Investment staff's proposed commitment levels for 2017.
